A) **RFQ** Process


Oman Tower Company would like to invite you to participate in this RFQ.

- 2. Clarification queries must be submitted to the same email address at least 1 working day before the bid submission deadline.
- 3. Offers must be valid for at least 30 days.
- 4. Bidders shall fill in their quotes in the schedule of price "Page2"
- 5. Oman Tower Company will first check the compliance with the technical evaluation, then only consider the commercial proposal of the technically qualified bidders.
- 6. The RFQ shall only be for bidders registered under the services of this categories and provide relevant document assuring the services.
- 7. Oman Tower at its discretion is not bound to award to the lowest bidder.
- 8. This RFQ does not commit OTC to award any work.
- 9. The bidder who will be awarded shall pay a registration fee; this is only applicable to unregistered bidders.
- 10. The bidder who will be awarded must be registered with Telecommunication Regulatory Authority (TRA)

### B) Scope of Work Summary.

- Oman Tower is requesting a proposal for service of design, Supply and installation of logo stickers for all the Camouflage & Lamppost towers owned by OTC.
- The Bidder shall provide the following service of Supply and installation of logo stickers for all the Camouflage & Lamppost towers owned by OTC.
  - Obtaining the relevant municipal approvals.
  - Installation and removal of advertising display.
  - Designing and developing any advertising logo.
  - Preparation of Mock-up Design for OTC's client upon request.
  - Provide overall two-year warranty for the sticker in terms of quality against weather conditions, color fade and any other damages.

#### **Technical Evaluation:**

- The bidder shall provide evidence of completion of similar works in the past 5 years such as: Purchase Orders, Letter of Intent or Letter of Award.
- The bidder shall provide evidence of having high up crane, boom lift, Man lift by proving their Registered license or Ongoing lease agreement.
- The bidder shall confirm delivery & installation period of the sticker from the issuance of work order shall not be exceed 4 Days by providing an official letter.
